## 1. INTRODUCTION

---

### Company:

Core Group Security Consultants is an investigations, protection, training and consulting company overseeing the implementation, integration and operation of security related matters, for **MME LLC**, in accordance to the draft of proposed regulations for Business Licensing from the City of Las Vegas for Medical Marijuana Establishments (MME).

We are a Nevada State licensed Private Investigator/Security Consultant as well as licensed Private Patrolman/Security Guard company. We are insured and have been in good standing since 2009, since the owners retiring from the United States Air Force. Core Group Security is a Combat Disabled Veteran, Minority Owned Small Business.

Our services include force protection, executive protection, close protection, advance details, risk assessment and travel security, surveillance and counter surveillance, paparazzi control, private investigation, skip-tracing, computer forensics, corporate counter-espionage and technical surveillance countermeasures/anti-eavesdropping. We also maintain a training school in the above mentioned skill sets, ([coregrouplv.com](http://coregrouplv.com)), and are member of Nevada Society of Professional Investigators.

### Owner Bio:

Owner of Core Group Security Consultants is Anthony E. Jones. He has been a Las Vegas resident since 1986. He served twelve years active duty and sixteen years as a Reserve Officer, retiring as a Major. In 2008, Major Jones was presented with the Key to the City by then Mayor Oscar Goodman, for achievements accomplished while deployed to Iraq.

As a civilian, he was the Director of Training for C.R.I. Training, an Israeli Counter Terrorism School that trains some of the top bodyguards and personal protection specialist in the world, as well as top military special operations personnel deploying to high risks zones in the Israeli method of Tier-1 operations. 88 courses in the last 9 years. Mr. Jones was medically retired due to injuries sustained during combat operations in Baghdad, Iraq. There he was the Director, Personnel Recovery Coordination Cell responsible for all Personnel Recovery, Search and Rescue and/or Combat Search and Rescue operations in the Iraqi Theater of Operations. He was also responsible for the training of all high risk of capture (HRC) personnel, for the repatriation of all isolated personnel, and for managing and tracking all Personnel Recovery assets in Iraq.

Prior to that Major Jones was a reservist, serving at Nellis Air Force Base, Nevada, where he oversaw Wing Core Compliance Programs, Battle staff Plans and Programs for Weapon's of Mass Destruction, Major Accident Response, Terrorist Incidents, Natural Disaster Response, Deployments, Nuclear Surety and Anti- Hijack Exercises.

**Risk Assessments and Mitigation:**

Because marijuana remains illegal under federal law, the banking and credit card industry is prohibited from servicing medical marijuana related accounts. This forces the **MME LLC** to operate on a all cash basis, for which there is a natural increase in risk to public safety. Having large amounts of cash and untraceable medical marijuana on hand can provide an opportunity to nefarious individuals or groups.

This cash and medical marijuana infused business will eventually find that criminal elements will seek to either become involved in or take advantage of the **MME LLC** assets. These criminal elements will target the patients, employees and surrounding neighborhoods if not thwarted from the start. We are extremely aware that this industry will be tested.

Risk of long term safety and security vs. inexpensive guard labor can lead to civil suits and higher insurance premiums. The threats are numerous; harassment, robbery, extortion, unruly patients and in this day and age of high technology, computer hacking (company/patient/employee records). In Colorado 18% of **MME** were robbed, with and estimated increase to 20-25% in 2014. This can and will be minimized by having in place a well trained and "tested under duress" Security Force on site.

Security will be addressed from the mandate, "Security and Safety from the Outside - In." The only way to keep employees, patients and the business safe is to have a well-equipped and trained force to deal with anything that may come up. The first line of defense is perimeter defense, with the Security Guards as the human de-escalation and protection action point. With a response time for most police agencies averaging nine minutes to high priority 911 calls, and most violent crime actions over in less than three minutes, a proven and trained Security Guard will be the difference.

Core Group Security has trained thousands of Private Security Operators, and will train all new Security Guards to the same standards. Our students have gone on to work with multiple security firms contracted to the State Department Worldwide Personal Protection Program, protecting high level Department of Defense personnel as well as Corporate executives throughout Iraq, Afghanistan and Africa.

Our current personnel are trained in Surveillance Detection and Counter Surveillance, Robbery scenarios, Active Shooter scenarios, Defensive tactics, threat de-escalation and mitigation. New Guards will be trained in the same curriculum, with bi-annual refresher training. Employees of the **MME** will also be trained in robbery scenarios, active shooter scenarios, threat de-escalation and mitigation. All training will be done by experienced "real world" operators. New employees will be former military, former police officer, veterans and first responders, with stress situation experience.
